## Rep. Metcalfe Leads Pennsylvania in Calling on Congress to Make Federal Tax Cuts Permanent

*State legislators urge congressional action.*

WASHINGTON— Today, Americans for Tax Reform (ATR), the nation's leading taxpayer advocacy group, praised Pennsylvania Representative Daryl D. Metcalfe (R-12) for his aggressiveness in protecting American taxpayers. In introducing a resolution urging Congress to permanently extend the successful federal tax cuts, Rep. Metcalfe is using the power of Pennsylvania's influence to shape congressional debate.

ATR's State Legislative Advisory Project was launched in 2001 in an effort to help give state legislators a louder voice in federal policymaking. In the project's first year, twenty-seven states passed resolutions urging their congressional delegations to support the Economic Growth Tax Relief Reconciliation Act. As of May, 2004, state legislators have already introduced 160 different resolutions in 40 legislative bodies in 27 states.

Taxpayer advocate Grover Norquist, president of ATR, praised Rep. Metcalfe's efforts. **“Americans for Tax Reform applauds Rep. Metcalfe for strengthening the voices of state legislators working to bring critical issues to the forefront of congressional debate. State legislators are intimately involved with their districts and their constituents. They should not shy away from offering valuable insight into the federal lawmaking process. Taxpayers in Pennsylvania are lucky to have a leader like Rep. Metcalfe who is willing to lead the legislature in just such a direction.”**

Rep. Metcalfe's resolution shows Pennsylvania's congressional delegates that their constituents expect action to protect the tax cuts. In Pennsylvania alone, more than 4.6 million taxpayers benefited from lower tax burdens as a result of President Bush's plan that cuts taxes for every taxpayer that pays income taxes, eliminated the marriage penalty, increased the child tax credit and provided small businesses with incentives to expand.

**“Taxpayers in Pennsylvania are waiting for the tax burdens they used to suffer under to be permanently lifted,”** said Norquist. **“It is the local leaders in the individual states that most closely represent the will of the people, and it is up to them to hold Congress accountable to the taxpaying citizens they represent.”**
